BILL UPDATES

As we approach summer recess in the Legislature, every bill must make it out of the other house's policy committees by July 3rd. As we wrap up Senate committee hearings, all fifteen of my bills are still moving through the Legislature and will next be considered in the Senate Appropriations Committee. My complete and updated bill package is detailed below:

BILL SPOTLIGHT



I recently presented <u>AB 828</u> before the Senate Natural Resources and Water Committee, and it passed with a 7-4 vote. AB 828 allows managed wetlands and small disadvantaged communities to use their average annual water usage without being subject to excessive fines by Groundwater Sustainability Agencies (GSAs) as part of the Sustainable Groundwater Management Act (SGMA).

AB 828 protects vulnerable communities and wildlife by safeguarding water supplies for small community water systems and California's managed wetlands, which will improve water quality, flood protection, recreation, and opportunities for scientific research.

At the end of June I presented <u>AB 2416</u> before the Senate Insurance Committee, and it passed with a 6-0 vote. AB 2416 requires the California Department of Insurance (CDI) to review the Safer from Wildfires regulations every five years, and consider if additional building hardening measures and community level wildfire mitigation programs should be included in the program.

The current state of the insurance market is leaving thousands of families without coverage and causing rates to rise even in areas that are low risk for wildfires and natural disasters. The Safer from Wildfires program is the only avenue open to consumers to receive direct insurance discounts for hardening their homes and neighborhoods.

AB 2416 helps consumers save money on their insurance bills while simultaneously reducing the risk of disaster for vulnerable communities. AB 2416 has passed successfully out of the Senate Insurance Committee, and the bill will now make its way to the Senate Appropriations Committee.

CPUC VOTE DENIES AT&T'S BID TO CUT LANDLINE SERVICE

In response to AT&T's petition to be relieved of its <u>Carrier of Last Resort</u> obligations and to remove its Eligible Telecommunications Carrier designation in areas of California, I sent a letter alongside my legislative colleagues to the California Public Utilities Commission (CPUC) President. This letter urges the CPUC to preserve landline services so that our residents in areas lacking reliable cellular service and are prone to natural disasters are protected. These legitimate public safety concerns have been voiced to my office by many longtime constituents, and I urged the CPUC to ensure critical communication services are preserved in all areas of California where cellular reception is unreliable and the potential for natural disasters or prolonged power outages are a recurring risk. On June 20, the CPUC voted to deny AT&T's bid to drop landline service that includes free access to 9-1-1 and other important services. I am pleased that the CPUC has considered the concerns of our constituents and has voted in favor of preserving these vital landline services.

RE: AT&T Petition to End Landline Service


Dear Ms. Reynolds:

I write to you to respectfully raise concerns on behalf of my constituents in Assembly District (AD) 12, which includes nearly 500,000 residents located in Marin and Southern Sonoma Counties, in relation to AT&T's applications to be relieved of its Carrier of Last Resort (COLR) obligations and to remove its Eligible Telecommunications Carrier (ETC) designation in areas of California.

In the North Bay and throughout the North Coast, many residents are located in areas, sometimes rural or heavily forested, where earthquakes, severe storms, floods, and catastrophic wildfires are common and cellular reception is unreliable. During these times, residents are only able to contact emergency services and obtain emergency updates via their landlines. Notably, even on a day with good weather, many of these areas still do not have reliable cellular service. These legitimate public safety concerns have been voiced to my office by many longtime constituents, particularly seniors, some who have never used a cellular phone and do not want to make the switch from their more reliable landline service.

As noted in a letter to the CPUC by my Congressional Colleagues in the California Delegation on February 20, 2024, hundreds of thousands of Californians were without power due to the Pineapple Express weather system storms, floods, and landslides this year. Additionally, the earthquake of 2022 left Californians without power for such an extended period of time, people were unable to charge their cellular phones. The only way to call for emergency services and stay in touch with the outside world was via neighbors that had landlines. I share my constituent's concerns that if landlines in these areas are removed, many North Bay residents will be stranded during times of emergencies. This potential scenario is unacceptable.

As the CPUC considers AT&Ts proposal to discontinue landline services in certain areas, I implore the Commissioners to ensure critical communication services are preserved in all areas of California where cellular reception is unreliable and the potential for natural disasters or prolonged power outages are a recurring risk. I join my Congressional colleagues in encouraging you to fully and fairly consider the concerns from our constituents in the districts that will be most impacted by the loss of landline services.



BUDGET ACT OF 2024

The Budget Act of 2024 has officially passed out of the California State Legislature, and I am celebrating some significant victories that save key investments and preserve funding for vital programs. The Budget Act, or Assembly Bill (AB) 107, preserves funding for programs that were proposed to be cut or eliminated entirely in the Governor's May Revise budget proposal. These programs include the Marine Mammal Center, adequate compensation for service providers for the developmentally disabled, the state's Active Transportation Program (ATP), and the California Nutrition Incentive Program (CNIP). Through my role on the Assembly Budget Committee and Assembly Budget Subcommittee No. 4 on Climate Crisis, Resources, Energy and Transportation, I was able to successfully advocate, alongside my legislative colleagues, to save funding for these programs through the creation of the Joint Legislative Budget Plan and the passage of AB 107.



The Marine Mammal Center, serving twelve marine mammal rescue organizations up and down the California Coast that rescue and rehabilitate stranded and injured marine mammals.



The <u>Developmental Services Provider Rate Reform</u>, increasing rates for providers who deliver care to people with developmental disabilities to address the widespread workforce shortage of direct care staff.



The <u>Active Transportation Program</u>, the state's primary funding source of local projects that encourage increased use of active modes of transportation, such as walking and biking.



The <u>California Nutrition Incentive Program</u>, encouraging low-income individuals using nutrition benefits to purchase locally grown, healthy California fresh fruits, vegetables, and nuts by providing incentives to shoppers at certified farmers markets and small businesses.



STATE MOUNTAIN BIKING MONTH

Early this month I presented ACR 152 on the Assembly floor, designating June 2024 as State Mountain Biking Month. California is widely recognized as the birthplace of mountain biking, with its roots beginning in Marin County in the late 1970s. I'm proud to promote responsible off-road cycling and mountain biking to encourage people to connect with their public lands, increase trail stewardship, and celebrate California's significant mountain biking culture, history, and incredible destinations.
