ELECTION DAY 2024

A big thank you to our AD12 community for showing up on Election Day! I am gratified to have received nearly 76% of the vote in our Assembly District, and I am looking forward to serving my second term as the North Bay's Assemblymember. It is my honor to be your representative in Sacramento, and I am thankful to every constituent.

I am proud to have authored thirteen bills that were signed into law by the Governor in my first session as an Assemblymember, and I look forward to more progress in the session to come. In addition to our local issues, I intend to prioritize the homeowners crisis around wildfire insurance, the high cost of utilities in the state, and making sure California continues to meet its clean energy goals in the upcoming session.

I am incredibly proud of everything we were able to accomplish as a community in my first legislative session as the North Bay's Assemblymember, and I look forward to working together in the legislative session to come.

LOOKING FORWARD

On the heels of the federal election results, it is more important than ever that we recommit ourselves to protecting California's progress and values. It is vital that we continue the push for progressive climate action, reproductive freedom for all, and our transition to a sustainable, clean energy future. In this upcoming legislative session as your California State Assemblymember, I pledge to keep fighting for that vision and working alongside each of you to tackle the issues that impact California and each of our diverse communities.

We are already preparing for these potential scenarios by convening a special session on December 2nd, where we will bolster our legal resources to fight back against federal policies that threaten immigrant families in our community or reverse our progress on important issues like climate change. My office is also working to bolster collaboration with our local nonprofits, legal aid organizations, and advocates to best determine how we can help our neighbors and community members who are uncertain about the future.

As a representative of the North Bay, I'll continue to fight for protecting our values and victories, while continuing to work on the issues that are most important to our community, like wildfire insurance, utility rates, the expansion of local clean energy resources, reducing barriers to healthcare, expanding active transportation options like bike paths, climate change, and securing funding through the Climate Bond for projects in our district.

Alongside my colleagues in the Legislature, I am preparing to fight hard for California's progress, and the issues most salient to our communities in the North Bay.



SAFER FROM WILDFIRES LEGISLATION

On day one of next year's legislative session, I plan on reintroducing my wildfire insurance bill, AB 2416. This bill would have required the California Department of Insurance to review the Safer from Wildfires regulations every five years, and consider if additional building hardening measures and community level wildfire mitigation programs should be included in the program.

The current state of the insurance market is leaving thousands of families without coverage and causing rates to rise even in areas that are low risk for wildfires and natural disasters. The Safer from Wildfires program is the only avenue open to consumers to receive direct insurance discounts for hardening their homes and neighborhoods.

Currently, there is no requirement for the California Department of Insurance to open up the regulations for evaluation. As new and safer building materials come to market and wildfire prevention methods evolve, it is important that we periodically revisit the regulations and ensure that as much relief as possible is being offered to residents who are doing the right thing.

This bill will help consumers save money on their insurance bills while simultaneously reducing the risk of disaster for vulnerable communities. This past session, the bill passed with bipartisan support but unfortunately did not receive a vote in the Senate. I plan on getting a new, stronger version of this bill passed and signed into law by the Governor in the new year, helping our California homeowners that are taking the initiative to harden their communities against wildfires.

As we head into storm season, let's make sure we are preparing for emergencies and taking care of our neighbors. Make an emergency plan, prepare for power outages, sign up for emergency alerts, and make sure you are familiar with our available community resources.
