BILL UPDATES

Each year, thousands of bills are introduced in the California State Legislature. These bills then travel through their respective policy committees, and are either passed or held in a twice-yearly procedure known as the suspense file hearing. The process releases hundreds of bills to the Assembly and Senate floors, where they can go up for debate and a vote before the entire chamber of lawmakers. Below is an update on which of my bills have passed out of the Assembly Appropriations Committee, including one of my bills that has already passed off the Assembly floor!





AB 1 strengthens the Safer from Wildfires program to offer insurance relief to people taking steps to harden their homes.

AB 540 clarifies and reforms civil procedure to make civil courts more efficient.

FIGHTING BACK AGAINST THE TRUMP ADMINISTRATION

As your proud representative, I am committed to standing up for the values that strengthen our communities and bring us together. The Trump administration's relentless attacks on our democracy, our institutions, and our most vulnerable communities will not go unanswered. The California State Legislature is fighting back against the chaos in Washington D.C. by introducing legislation to enshrine voting rights, protect reproductive freedom, and progress our climate goals. Together, we can defend our California values.



<u>AB 260</u>, authored by Assembly Majority Leader Aguiar-Curry and sponsored by Planned Parenthood Affiliates of California, reaffirms California's commitment to protecting reproductive healthcare. This bill outlines protections for healthcare providers, shielding them from being penalized for providing mifepristone or other reproductive care. The bill enhances prescriber safety, expands access through telehealth services, and eliminates outdated and discriminatory language from state law. AB 260 passed off the Assembly floor this month with 61 "AYE" votes.



AJR 3, which I was proud to coauthor alongside Assemblymember Schiavo and 72 of my legislative colleagues, opposes cuts to Social Security, Medicare, and Medicaid. This resolution calls on California's Congressional representatives to support legislation to protect and improve these systems to strengthen their protections, and calls on the United States President to honor his campaign promise to neither to cut or defund these programs, and to work with Congress to protect and improve them. AJR 3 passed off the Assembly floor this month with 64 "AYE" votes.



FIGHTING BACK AGAINST THE TRUMP ADMINISTRATION

The Legislature is not California's only branch of government making bold strides to stand up to the Trump administration. During Trump's first term, California sued the federal government 123 times, and won more than two out of every three cases. In response to the influx of executive orders in the first 100 days of Trump's second term, California is leading nine multi-state lawsuits, has joined more than eleven lawsuits led by other states, and is the first state to sue the federal government over its tariff policies. A summary of each of the lawsuits California has initiated or joined can be found below:





NONPROFIT OF THE YEAR

On May 21st, I had the honor of recognizing Mount Tamalpais College as the 2025 Nonprofit of the Year for Assembly District 12. Mount Tamalpais College provides a high quality and inclusive Associate of Arts degree program and College Preparatory program to individuals incarcerated at the San Quentin Rehabilitation Center. The program, which is free of charge, aims to expand access to quality higher education for incarcerated people and foster the values of equity, civic engagement, and freedom of expression.

According to the Department of Justice, inmates who participate in correctional education programs have approximately <u>43 percent</u> lower odds of returning to prison than those who do not, and every dollar spent on prison education saves four to five dollars on the costs of re-incarceration.

Mount Tamalpais College has been a beacon of opportunity and transformation for nearly three decades. Since its founding in 1996 as the Prison University Project, the institution has provided tuition-free Associate of Arts degrees and college preparatory programs to incarcerated students, fostering academic excellence, personal growth, and the tools for meaningful reintegration. In 2022, Mount Tamalpais College achieved a historic milestone by receiving full accreditation from the Accrediting Commission for Community and Junior Colleges, becoming the first fully accredited, independent college based inside a U.S. prison.

I was proud to honor Mount Tamalpais College at the California State Capitol, recognizing their unwavering dedication to expanding access to quality higher education and its role in fostering a more just and equitable society. By expanding access to higher education among incarcerated people in California, we can work to break the cycle of recidivism and provide inmates with the tools they need to success upon their release.



MEMORIAL DAY

This Memorial Day, I was honored to join the Marin County Veteran's Office in San Rafael for their annual Memorial Day tribute, honoring the brave individuals who made the ultimate sacrifice for our country. We then came together as a community for the Mill Valley Memorial Day Parade, in a solemn reminder of the sacrifices our veterans made for our freedom. I am deeply grateful to our veterans, service members, and their families for their dedication and sacrifice.
